General Board Meeting - Minutes Wednesday, June 25, 2025, 7:30pm @ Kolb Field

2. Public Comment

a. Jamie Canvin

- i. Asked why some meetings are general and others are Executive Board only.

- iii. Asked for clarification on when bylaws are amended and will it be addressed prior to next year's 12u fundraising.
- iv. Asked if the "free" 11u team for 2026 will affect the 12u fundraising.
 - 1. Jeff Wendt and Dennis Sepessy replied that the perspective manager has specific fundraising that will not interfere with 12u.
- v. The question of tournament fundraising was raised again.
 - 1. Alisa Trovato stated that the board would like to have the teams present before tourneys are run to discuss the percentage that would go back to the teams.
- vi. Asked what board positions will be up for election in August.
 - 1. President, Recording Secretary, Sponsorship, Equipment and Boys' President
 - 2. Must have been present at 75% of the previous general meetings.
